NATIONAL FUNDING PROGRAMMES

A B CHARITABLE TRUST

<http://abcharitabletrust.org.uk/index.htm>

What is it for?

Human rights and support to disadvantaged communities.

Who can apply?

Charities registered and working in the UK and with an annual income of between £150,000 and £1.5m, but with no substantial investments or reserves

What is available?

Most grants awarded are in the range of £10,000 to £20,000

Applications are particularly welcomed from charities working to support:

- Refugees and asylum seekers
- Prisoners and penal reform
- Human rights

How to apply?

Read the application notes at http://abcharitabletrust.org.uk/application_notes.pdf before applying. Apply online at <http://abcharitabletrust.org.uk/application.htm>. The Trustees meet four times a year, in January, April, July and October. The next application deadline is **19 May 2017**.

Note: The reporting date of your certified accounts / statements, must be no more than 12 months prior to the application deadline.

ALLEN LANE FOUNDATION

What is it for?

Grants are available to for work, including advice, advocacy, befriending and other activities, that make a difference to people's lives as opposed to simply alleviating the symptoms or current problems and should aim to reduce isolation, stigma and discrimination.

Who can apply?

Small registered charities, voluntary groups and charitable organisations in the UK helping at least one of the following groups:

- Asylum seekers and refugees*
- Gypsies and Travellers
- LGBTQ communities
- Migrant communities*
- Offenders and ex-offenders
- Older people
- People experiencing mental health problems
- People experiencing violence or abuse

NATIONAL FUNDING PROGRAMMES

* Organisations working with single nationalities are not eligible.
Work benefitting people only in the Greater London area will also not be funded.

What is available?

Up to £15,000.

How to apply?

Apply anytime. Email or post a written application no more than four sides of A4 addressing questions found at <http://allenlane.org.uk/apply/> along with a registration form <http://allenlane.org.uk/registration-form/>.

AWARDS FOR ALL

What is it for?

Activities that benefit the community.

Who can apply?

Community groups, not for profit groups, parish or town council, health body, or school. You do not need to be a registered charity to apply.

What is available?

£300 - £10,000

How to apply?

Email the completed form at least 4-5 months before you want your project to start. Contact details for the different part of the programme via the links.

BALCOMBE CHARITABLE TRUST

What is it for?

Charitable activities in the UK for young, homeless and/or unemployed not in education (NEETs). Projects on helping young women in this situation are particularly welcome.

Who can apply?

NATIONAL FUNDING PROGRAMMES

UK registered charities, or a charitable organisation which is exempt from registration with an annual turnover of between £500,000 and £5,000,000 (Between £500,000 and £3,000,000 for small grants).

What is available?

£15,000 and £50,000

How to apply?

Email lee@balcombetrust.org.uk including a short proposal (maximum 1,000 words) plus a copy of your latest annual report and financial statement between 10 April and **31 May 2017**. Shortlisted applicants will then be invited to submit a more detailed proposal.

BARROW CADBURY TRUST

What is it for?

Criminal justice, migration, and economic justice

Who can apply?

Mostly organisations working nationally. Where local work being carried out, this is nearly always in Birmingham and the surrounding area.

What is available?

Grants fall under three programmes – criminal justice, migration, and economic justice. No lower or upper limits are specified.

How to apply?

Apply at any time. Go to <https://www.barrowcadbury.org.uk/what-we-do/programmes/>, click on the appropriate programme area and follow the links to complete an online enquiry form. You should only complete an application form after speak to the trust.

BBC CHILDREN IN NEED

What is it for?

Work to combat disadvantage faced by children and young people aged 18 and under. Such disadvantage includes:

- Illness, distress, abuse or neglect
- Any kind of disability
- Behavioural or psychological difficulties
- Living in poverty or situations of deprivation

Who can apply?

NATIONAL FUNDING PROGRAMMES

Not-for-profit organisations that work with disadvantaged children and young people of 18 years and under who live in the UK, the Isle of Man or the Channel Islands.

What is available?

Small Grants of up to £10,000 per year for up to three years

Main Grants over £10,000 per year for up to three years (no upper limit but generally not over £120,000 (or £40,000 per year).

BBC Children in Need will consider funding support costs associated directly with a project, but are unable to fund organisational overheads and running costs where these are not integral to the project you are applying for.

How to apply?

Main Grants – Next application deadline will be in **1 June 2017**. Two-stage process with notification a few weeks after submitting your initial application and one month to complete full application form if invited to stage 2. You will need to be available in the month after you submit your full application for a telephone assessment. Your referee will also need to be available during this time to provide a reference. BERNARD SUNLEY CHARITABLE FOUNDATION

What is it for?

Capital projects only under a range of themes: Community; Education; Health; Social Welfare

Who can apply?

Must be a charity registered with the Charity Commission for England and Wales to apply. Check eligibility criteria for further details <http://www.bernardsunley.org/eligibility.html>.

What is available?

There are 3 levels of grant:

- Small – £1,000 to £5,000
- Medium – £5,001 to £24,999
- Large – £25,000 or more

NB: Projects with a total budget of under £3,000 should not apply. Most of the grants given are £5,000 or below.

How to apply?

What is it for?

Human Rights, Prison Reform, Environment

Who can apply?

UK registered charities

What is available?

No set amount, though previous grants have ranged from £5,000 to £20,000.

How to apply?

CHARLES HAYWARD FOUNDATION – MAIN GRANTS PROGRAMME

What is it for?

Charitable organisations working in one of three priority areas: Social and Criminal Justice; Heritage and Conservation; and Overseas

Who can apply?

UK registered charities with an annual income of more than £350,000

What is available?

Funding amounts vary for each priority area. For the Social and Criminal Justice programme, grants of £15,000 – £25,000 per annum over 1-3 years is available for project costs and capital expenditure or up to £25,000 for a pilot project

The **Social and Criminal Justice** priority area funds activities under the following sub-categories:

- Targeted early intervention programmes aimed at reaching the most troubled and vulnerable families in a community
- Preventative and diversionary projects for young people at risk of offending including tailored interventions identifying and addressing the needs of girls and young women
- Programmes, particularly those with a focus on young offenders, combining prison based and community interventions
- Schemes offering alternatives to custody, particularly for women and young people
- Programmes of support directed towards rehabilitating the victims of domestic abuse and criminal exploitation

NATIONAL FUNDING PROGRAMMES

How to apply?

Application for the Social and Criminal Justice strand is by letter with applications considered every 2-3 months. A Grant Committee meets on a quarterly basis and recommends applications for consideration at a separate Trustees' meeting, usually held in February, April, July and November. CLOTHWORKERS FOUNDATION - MAIN GRANTS PROGRAMME

What is it for?

Addressing the needs of disadvantaged communities

Who can apply?

Not for profit organisations with annual turnover under £15,000,000. You must demonstrate in your application that the majority of the services you deliver fall under one or more of the following programme areas:

- **Alcohol and substance misuse** – projects supporting people affected by, or at risk of, drug and/or alcohol dependency, and their families.
- **Disability** – projects providing services for people with physical and/or learning disabilities, and/or for people with mental health issues. (We will not fund projects which focus only on meeting the requirements of the Disability Discrimination Act)
- **Disadvantaged young people** – projects which support disadvantaged young people, particularly (but not limited to) those in or leaving care, or not in employment education or training (NEET).
- **Domestic and sexual violence** – projects supporting people affected by domestic or sexual violence
- **Elderly** – projects providing services for elderly people, in particular those living in areas of high deprivation and/or where rural isolation is an issue.
- **Homelessness** – projects providing services for people who are homeless or at risk of becoming homeless.
- **Integration of disadvantaged minority communities** – projects providing services to disadvantaged minority communities, in particular projects which promote integration and access to mainstream services.
- **Prisoners and ex-offenders** – projects supporting prisoners and/or ex-offenders, or those at risk of offending, and their families
- **Visual impairment** – projects providing services for blind or visually impaired people.

What is available?

No upper limit but grants tend to be for around £25,000 for capital costs for projects. Further information at <http://foundation.clothworkers.co.uk/Open-grant-programmes/Main-and-Small-Grant-Programmes.aspx>

How to apply?

NATIONAL FUNDING PROGRAMMES

There is a rolling programme of funding meetings, so there is no deadline for submitting an application. The turnaround time for the main grants programme is 6 months. COMIC RELIEF - BUILDING STRONGER COMMUNITIES PROGRAMME

What is it for?

Charitable activities building stronger communities in areas of disadvantage, deprivation and poverty

Who can apply?

Charitable organisations delivering activities in the UK

What is available?

Comic Relief have relaunched a revised grants strategy found at <http://www.comicrelief.com/news/comic-relief-launches-grants-strategy>
Comic Relief's Stronger Communities theme is run by UK Community Foundations and include:

- **Local Communities (grants of £1,000 to £10,000)** – Check with local community foundations for deadlines.
- **Community Cash (grants of £500-£1,000)** - currently closed for applications. Community Cash runs alongside Comic Relief's annual Campaign and local media partners across the UK.
- **Large Grants (grants up to £30,000)** - nominated by community foundations and chosen by Comic Relief every year.

How to apply?

Apply via local community foundations.

What is it for?

Activities that benefit disadvantaged people and communities

Who can apply?

Registered charities, including those registered as a company limited by guarantee and CIOs, that operate at city or county level and have an annual income greater than £200,000 and less

NATIONAL FUNDING PROGRAMMES

than £10 million. The Trust does not support charities where the main beneficiaries are in Greater London or in Northern Ireland.

What is available?

Usually £25,000 to £35,000, generally over 1 year, but grants for up to 3 years awarded occasionally.

How to apply?

Apply anytime. Trustees meet February, June and October and the selection process normally takes between 3 and 6 months. Current high demand for funding means that new applications will be decided on in June 2017 at the earliest.

EBICO TRUST

What is it for?

Fuel poverty projects in fuel-poor neighbourhoods in England, Scotland and Wales, including advice, guidance or education projects; sustainable improvements to energy efficiency; or research into fuel poverty

Who can apply?

Organisations working to tackle fuel poverty

What is available?

Up to £60,000, with grants usually ranging from £20,000 to £60,000

How to apply?

Applications are considered quarterly. The next meeting takes place in May so applications will need to be in by about mid-March 2017. Check the website for exact deadlines and download an application form at <https://ebico.org.uk/trust/how-to-apply-for-funding/> and submit by email or post.

ESMEE FAIRBAIRN TRUST – SOCIAL INVESTMENT

What is it for?

Enabling disadvantaged people to participate fully in society

Who can apply?

A wide range of organisations can apply. In the case of non-registered charities, a copy of the constitution must be provided to check that there is sufficient public benefit and protection against private gain.

What is available?

Grants to support organisations' core or project costs, including staff salaries and overheads. 2014 grants ranged from £6k to £1.25m (median average £90,000), over 1 to 5 years.

Grant applications are accepted for one of four areas of interest – the arts, children and young people, the environment and social change. The Foundation like to consider work which others may find hard to fund, perhaps because it breaks new ground, appears too risky, requires core funding, or needs a more unusual form of financial help such as a loan.

How to apply?

First stage applications can be made at any time. Successful applicants will be advised by the Foundation on how to proceed to stage two. Visit

Social welfare projects for elderly people

Who can apply?

UK registered charities churches, hospitals, educational establishments, housing associations

What is available?

Up to £50,000, but most grants are for around £5,000

How to apply?

GARFIELD WESTON FOUNDATION

What is it for?

The Foundation supports activities across the UK on a wide range of topics, capital projects and core costs

Who can apply?

UK registered charities churches, hospitals, educational establishments, housing associations

What is available?

There is no limit to the size of grant; however, funding is for a single year and applicants should have secured a significant proportion of funding prior to applying to the Foundation.

Organisations need to demonstrate how the funds can make the most difference – either by funding core costs (not salaries); or funding a specific project.

How to apply?

Applications and supporting documents must be sent by post. Apply anytime and allow approximately 4 months for a final outcome; <http://www.garfieldweston.org/how-to-apply/>

THE HENRY SMITH CHARITY

What is it for?

A wide range of priority groups are listed on the website and activities including advice, advocacy and other support work.

Who can apply?

UK-based not-for-profit organisations.

What is available?

Revenue grants of £10,000 or over, though generally range from £20,000 to £30,000 per year for two or three years.

How to apply?

Apply anytime for an outcome within 6 months. Application forms and guidelines available to download from <http://www.henrysmithcharity.org.uk/main-grants-programme.html>

NATIONAL FUNDING PROGRAMMES

What is it for?

Priorities include welfare which is for people facing poverty, hardship and other forms of disadvantage. The two areas funded are:

- realising individual potential
- strengthening personal and social networks.

Who can apply?

Registered charities (or exempt organisations) from any part of the UK whose work has impact across the whole of the UK as well as those working across England.

What is available?

Minimum grant is £10,000. No upper limit but grants over £100,000 are unusual. Grants are generally over 2 or 3 years. Core or project costs funded.

How to apply?

Apply anytime. Two stage application process starting with two sides of A4 and some financial information. More information at <http://ellerman.org.uk/how-to-apply>

Who can apply?

Organisations which promote human rights, access to justice, legal education

What is available?

Grants are normally in the range £5,000 - £15,000

How to apply?

LEGAL EDUCATION FOUNDATION

What is it for?

Activities promoting the advancement of legal education and the study of law.

Who can apply?

A range of organisations are eligible to apply.

What is available?

No specified amount, though grants tend to range from about £10,000 to £100,000 for activities which cover one or more of the following objectives:

- To increase public understanding of the law and the capability to use it.
- To advance high quality thinking, training and practice in legal education and legal services so as to ensure legal needs are met.
- To increase access to employment in the legal profession and, in particular, to advance social mobility and diversity.
- To develop a robust evidence base of needs in each of the areas above and of effective ways of meeting these needs.
- To understand the role that technology can play in achieving each of these objectives.

How to apply?

Who can apply?

UK registered charities, companies limited by guarantee, community interest companies.

- If you work locally or in a region you must have an income of £1 million or less
- If you work nationally you must have an income of £5 million or less

What is available?

Funding is available for 1 to 3 years. The level of funding awarded is based on the needs and size of the organisation. Funding is for charities to continue and develop existing community-based work, or to develop the organisation or its services.

How to apply?

Enable Grants can be applied for on an ongoing basis. Invest grants are currently not accepting funding applications, so check the website for the next round. In order to access funding organisations will have to confirm eligibility by completing a questionnaire online or over the phone 0870 411 1223. See the website for further details <https://uk.porticus.com/en/programme-areas>. Specific project costs covered, though Porticus also consider funds to help develop policy, advocacy and research. Particular interest in organisations with a proven model that they wish to roll-out or expand.

- People have better chances in life, with better access to training and development to improve their life skills,
- Stronger communities, with more active citizens, working together to tackle their problems,
- Improved rural and urban environments, which communities are better able to access and enjoy,
- Healthier and more active people and communities.
